Though I don't know if you're ALREADY engaged in writing and corresponding with someone, or if you're in such a position, or HAVE A interest to write with anyone AT ALL? But "if" there's a possibility, or opportunity of your interest to be open and dedicating to the cause, I'm interested in wanting to know if I CAN fulfill a moment of your time, in the regards of you and I EXCHANGING CORRESPONDENCES? BECAUSE I'm "desperately", within a need of engaging someone like you that's sincerely dedicating, supportive, business and activist minded as you are. HOWEVER, if you should ALREADY have yourself AN overworked busy scheduled schedule, then I'd like to ASK and REQUEST that if it's possible you could connect me up with ANGELA etc.... Though I'm requesting this favor from you in GREAT hopes of faith that, you'll be able to aid and assist me. BECAUSE first of all, being that I'm A TEXAS DEATH ROW PRISONER...
